Why Does the Team Matter?

2. We are grateful the fair board is considering us as well as grateful the county and state are considering us for this historic event. We agree the board should be cautious about who they allow to do these events as we do not believe all teams have the considerable talent and experience as our team. To that end choosing the right team matters, and there is no better team than this one.

What Are We Proposing to Do?

- 1. It was our Vision to offer a local option to compete with the Coachella music festival on the same two weekends as Coachella, and we are here to request the opportunity to manifest this Vision.
- 2. We are requesting the opportunity to throw a two-day event on April 16 and 17.
- 3. The event will be 21 and over and have live music, food, retail vendors, carnival games, and maybe a few carnival rides, and cannabis vendors selling cannabis for onsite consumption.
- 4. The event starts at 11 am and ends between 10 pm and 12 am Cannabis not to be sold after 10 pm.
- 5. Live music will go dark at 10 pm sharp.
- 6. We would love green fireworks on Saturday night.
- 7. The types of cannabis we are requesting to sell and use at the event include, cannabis flower, concentrates, cartridges (like vapes), edibles, and drinks as well as medicinal topicals and creams.
- 8. We are requesting the opportunity to do this event every year for 3 years but with two weekends instead of one (basically the weekends of Coachella), with a 7 year option after that.
- 9. Site Plan Exhibited.

General Processes and Laws

- 1. **Approvals**: A cannabis event in Riverside County must have:
 - a. A cannabis event license (license exhibited),
 - b. Fair Board Approval (in process application exhibited),
 - c. County Approval (in process application number exhibited),
 - d. A state specific event license (in process and dependent on county approval which is dependent on Fair Board approval).
 - e. A cannabis retail licensee (license exhibited: Empire Gardens).

2. County Ordinance: (Exhibited)

- a. Cannabis events can occur on County Fair property or District Agricultural Association property.
- b. Must have a County CUP and State Specific Cannabis Event Permit.
- c. Cannot sell alcohol or tobacco.
- d. Cannot allow under 21 persons to view usage (it's an over 21 show).
- e. Must have security.

- 3. State Law: (Exhibited)
 - a. Must have general and specific event licenses.
 - b. Section 15601- "A temporary cannabis event license authorizes...the <u>onsite sale and</u> <u>consumption</u> of cannabis..." in a specific location and on a specific date.
 - c. The event premises cannot include any sale of alcohol or tobacco.
 - d. All security must be over 21.
 - e. Required signage: "No Persons Under the Age of 21 Allowed".
 - f. ID check at sale (even if checked to get in).
 - g. All sales must be by a licensed retailer and through METRC (state tracking system).
 - h. Smoking of cannabis shall be prohibited any place it is prohibited by law (near buildings, inside, etc.).

- 4. **Safe Consumption Plan** (Exhibited): Impaired Driving Task Force.
 - a. Full plan exhibited: Signage, education, and training requirements by state of California.
 - b. ID checked every time cannabis is purchased regardless of wristband.

Event Specifics:

- 1. **Security**: Cannabis shall be stored in secured areas and there will be 3 sets of security as well as METRC tagging on all products:
 - 1. Retail security (licensed and can be armed if necessary)- This security is solely for securing retail operations, cash, and cannabis. We will likely have 4-6 depending on inventory.
 - 2. Cannabis event licensee security- This security is for the cannabis event premises. Number TBD on ticket sales, no less than 10 and must be over 21.
 - 3. Event Security- Hopefully we can use Oscar if he would like and the number TBD (must be over 21).
 - 4. *Note we may also invite Sheriffs if we feel it's necessary.
 - 5. *METRC- All cannabis is tagged and entered into the state inventory system.
 - 6. Bottom Line: Security is important to us and this first event going well is important to us, it will be a safe and secure environment (period).

2. Requested Edits to Fair Policy and Related Actions:

- a. Adoption of state/county laws relating to cannabis events, specifically, the use and consumption on site.
- b. The allowance for smoking on the premises in accordance with state law <u>during cannabis</u> events only.
- c. Approval of the event and long-term partnership.

3. Revenue Sources: Numbers/Offer

- a. Application Edit: After consulting with Don who knows more about production than me, he indicated we should plan for 2000+ persons the first year, and if more attend then we will be prepared in advance.
- b. \$10 dollars for parking.
- c. \$25-\$40 for admission.
- d. The event will be charging vendors to participate (typically a flat fee when percentages are prohibited (it is prohibited for an event organizer to charge a percentage of cannabis sales), however, we will be charging vendors in general.
- e. **Costs**: The event will be labor/talent and marketing intensive (Astro turf, places to sit, installation elements, carnival games/rides, fireworks, etc). This costs money.
- f. Offer: A long term partnership wherein the festival and the fairgrounds can benefit and be improved. 10% of net income from G.A. tickets-gate, 10% food and beverage, \$3 per vehicle, plus flat rate two day rental fee(s) \$10,000.00. Questions?



County Cannabis Event Ordinance

ORDINANCE NO. 348.4966 AN ORDINANCE OF THE COUNTY OF RIVERSIDE PROVIDING FOR LAND USE PLANNING AND ZONING REGULATIONS AND RELATED FUNCTIONS. ARTICLE XIXh COMMERCIAL CANNABIS ACTIVITIES

The Planning Director shall approve an application for a temporary Cannabis event permit if all of the following are met:

- 1. The temporary Cannabis event will take place on County Fair property or District

 Agricultural Association property.
- 2. The temporary Cannabis event is not located within 1,000 feet from any Child Day Care Center, K-12 school, public park, or Youth Center. Distance shall be measured from the nearest point of the respective lot lines using a direct straight-line measurement.
- 3. The temporary Cannabis event will not occur during the hours of 12:00 a.m. to 6:00 a.m.
- 4. The temporary Cannabis event is setback a minimum of 100 feet from lot lines.
- 5. The sale of Cannabis Products shall be performed by a Cannabis Retailer or Cannabis Microbusiness that possesses both an approved conditional use permit and a valid Cannabis license from the State, which shall be included in the permit application.
- 6. The sale or consumption of alcohol or tobacco is not allowed at the location of the temporary Cannabis event.
- 7. The event organizer for the temporary Cannabis will obtain a valid State event organizer license authorizing the retail sale of Cannabis goods and the temporary Cannabis event.
- 8. Access to the area(s) where sale or consumption of Cannabis occurs is restricted to persons 21 years of age or older.
- 9. Cannabis consumption is not visible from any public place or non-age-restricted area.
- 10. Security shall be present at the temporary Cannabis event.
- 11. A condition of approval shall be applied to all temporary Cannabis event permits requiring the event organizer to obtain a valid State license as an event organizer and for the temporary event at least 10 calendar days before the event's first day. If this condition of approval is not met, the temporary Cannabis event permit becomes null and void.

B. APPLICATION.

No less than 120 days from the event's first day, an event organizer shall apply for and obtain a temporary Cannabis event permit in accordance with Section 18.30 of this ordinance. All the procedural provisions of Section 18.30 shall apply to the application, except subsection c. thereof relating to requirements for approval, subsection e. thereof relating to appeals and subsection f. thereof relating to the use of the permit after the application is approved.

C. REVOCATION.

ORDINANCE NO. 348.4966 AN ORDINANCE OF THE COUNTY OF RIVERSIDE PROVIDING FOR LAND USE PLANNING AND ZONING REGULATIONS AND RELATED FUNCTIONS. ARTICLE XIXH COMMERCIAL CANNABIS ACTIVITIES

A temporary Cannabis event permit may be revoked pursuant to and in accordance with Section 19.525 of this ordinance.

<u>SECTION 19.525.</u> <u>REVOCATION OF PERMITS FOR COMMERCIAL CANNABIS ACTIVITIES.</u>

Any conditional use permit granted under this Article may be revoked upon the findings and procedures contained in Section 18.31 of this ordinance except that the Planning Commission shall be the hearing body to make a determination that grounds for revocation exist and provide notice of the revocation. All other procedural requirements and rights of appeal set forth in Section 18.31 of this ordinance shall govern the hearing.

State Event Ordinance

(k) A suspension or revocation of a microbusiness licensee shall affect all commercial cannabis activities allowed pursuant to that license.

Authority: Section 26013, Business and Professions Code. Reference: Sections 26012, 26050, 26051.5 and 26070, Business and Professions Code.

Chapter 5. Cannabis Events

§15600. Cannabis Event Organizer License.

- (a) To obtain a temporary cannabis event license, the event organizer must first apply for and obtain a cannabis event organizer license.
- (b) A cannabis event organizer licensed under this section shall comply with chapter 1 of this division except for sections 15006, 15007, 15010, 15019, 15025, 15027, 15034, 15038, 15042, 15044, and 15046-15052.1.
- (c) A cannabis event organizer licensee is not authorized or licensed to cultivate, distribute, manufacture, or retail cannabis or cannabis products without first obtaining the appropriate licenses or authorizations to engage in such commercial cannabis activities.

Authority: Section 26013, Business and Professions Code. Reference: Sections 26012 and 26200, Business and Professions Code.

§15601. Temporary Cannabis Event Requirements.

- (a) A temporary cannabis event license authorizes a licensed cannabis event organizer to hold a temporary cannabis event where the onsite sale and consumption of cannabis goods is authorized at the location indicated on the license during the dates indicated on the license.
- (b) Violations of the requirements applicable to temporary cannabis events may result in disciplinary action against the cannabis event organizer license or any other licenses held by a licensee participating in the temporary cannabis event and responsible for a violation under this division or the Act.
- (c) A temporary cannabis event license shall only be issued for a single day or up to 4 consecutive days. No temporary cannabis event license will be issued for more than 4 days.
- (d) An application for a temporary cannabis event license shall be submitted to the Department no less than 60 calendar days before the first day of the temporary cannabis event.
- (e) A temporary cannabis event may only be held at a county fair event, district agricultural association event, or at another venue expressly approved by a local jurisdiction for the purpose of holding a temporary cannabis event.
- (f) A temporary cannabis event license shall not be issued for a premises that is licensed for the sale of alcohol or tobacco.
- (g) If the list of licensees and employees participating in the temporary cannabis event changes after the application is submitted or after the license is issued, the applicant

shall submit with the Licensee Notification and Request Form, Notifications and Requests Regarding Regulatory Compliance, DCC-LIC-028 (New 9/21), incorporated herein by reference, an updated list and an updated diagram, as required in section 15002.1(b)(5), to the Department no less than 72 hours before the event. Licensees not on the list submitted to the Department shall not participate in the temporary cannabis event.

- (h) The licensed cannabis event organizer shall hire or contract for security personnel to provide security services at the licensed temporary cannabis event. All security personnel hired or contracted for by the licensee shall be at least 21 years of age, licensed by the Bureau of Security and Investigative Services, and comply with chapters 11.4 and 11.5 of division 3 of the Business and Professions Code. Security personnel shall be present on the licensed premises at all times cannabis goods are available for sale and/or cannabis goods consumption is allowed on the licensed premises.
- (i) A licensed cannabis event organizer shall maintain a clearly legible sign not less than 7 inches by 11 inches in size, reading "No Persons Under 21 Allowed" at or near each public entrance to any area where the sale or consumption of cannabis goods is allowed. The lettering of the sign shall be no less than 1 inch in height.
- (j) All cannabis waste generated at a temporary cannabis event shall be collected and disposed of in accordance with the requirements of section 17223. The licensed cannabis event organizer may contract or arrange for the collection and disposal of cannabis waste generated during the temporary cannabis event.
- (k) A licensed cannabis event organizer and all other licensees participating in a temporary cannabis event are required to comply with section 15037 and all other applicable requirements in the Act and this division pertaining to record keeping.
- (I) The Department may require the event organizer and all participants to cease operations without delay if, in the opinion of the Department or local law enforcement, it is necessary to protect the immediate public health and safety of the people of the state. Upon notification from the Department that the event is to cease operations, the event organizer shall immediately stop the event and all participants shall be removed from the premises within the time frame provided by the Department.
- (m) Upon notification from the Department, the event organizer shall immediately expel from the event any person selling cannabis goods without a license from the Department that authorizes the participant to sell cannabis goods. The event organizer or their representative shall remain with the person being expelled from the premises at all times until he or she vacates the premises. If the person does not vacate the premises, the Department may inform the event organizer that the event must cease operations. Upon notification from the Department that the event is to cease operations, the event organizer shall immediately stop the event and all participants shall be removed from the premises within the time frame provided by the Department.

Authority: Section 26013, Business and Professions Code. Reference: Sections 26012 and 26200, Business and Professions Code.

§15602. Temporary Cannabis Event Sales.

- (a) Only persons age 21 or older may purchase and consume cannabis goods at a temporary cannabis event. Prior to selling cannabis goods to a customer, the licensee making the sale shall confirm, using valid identification as specified in section 15404 of this division, the age and identity of the customer.
- (b) All sales of cannabis goods at a temporary cannabis event must occur in a retail area as designated in the premises diagram pursuant to section 15002.1(b)(5) of this division.
- (c) Each sale at a temporary cannabis event shall be performed by a licensed retailer, a licensed non-storefront retailer, or licensed microbusiness that is authorized to engage in retail sales. The cannabis event organizer may also sell cannabis goods at the temporary cannabis event if the organizer separately holds a license authorizing the retail sale of cannabis goods.
- (1) Licensed retailers or licensed microbusinesses shall only conduct sales activities within their specifically assigned area, identified in the diagram of the physical layout of the temporary cannabis event.
- (2) Mobile sales activities via wagon, cart, or similar means are prohibited at the temporary cannabis event site.
- (d) Licensed retailers or licensed microbusinesses must prominently display their temporary cannabis event location number and state license within plain sight of the public.
- (e) All sales at a temporary cannabis event shall occur on the dates stated on the license and shall occur at the location stated on the license. All onsite sales of cannabis goods must comply with the hours of operation requirements of section 15403 of this division.
- (f) Sale of alcohol or tobacco shall not be allowed on the licensed temporary cannabis event premises.
- (g) The cannabis goods sold onsite at a temporary cannabis event shall be transported by a licensed distributor or licensed microbusiness in compliance with the Act and this division. All shipments of cannabis goods and non-cannabis goods intended for sale at a temporary cannabis event must be checked by the temporary cannabis event organizer staff to prevent prohibited items, such as alcohol and tobacco, from entering the licensed premises.
- (h) Except small amounts of cannabis goods used for display, all cannabis goods for sale at a temporary cannabis event shall be stored in a secure, locked container that is not accessible to the public. Cannabis goods being stored by a licensee at a temporary cannabis event shall not be left unattended. Licensees may share the secure, locked container; however, each licensee using the container shall be held responsible for any violations of this section and subject to disciplinary action.
- (i) All cannabis goods made available for sale at a cannabis event shall comply with all requirements for the retail sale of cannabis goods within the Act and section 15406 of this division.
- (j) All cannabis goods made available for sale at a temporary cannabis event shall

comply with all track and trace requirements within the Act and this division.

- (k) All cannabis goods used for display at a temporary cannabis event shall comply with the requirements of section 15405 of this division.
- (I) All cannabis goods sold at a temporary cannabis event shall comply with section 15413 of this division.
- (m) All customer returns of cannabis goods at a temporary cannabis event shall comply with section 15410 of this division.
- (n) The daily sales limits under section 15409 of this division apply to all sales made at a temporary cannabis event.
- (o) A licensed retailer shall only provide free cannabis goods to a person at a temporary cannabis event if the licensed retailer complies with all requirements of section 15411 of this division.
- (p) The licensed cannabis event organizer shall be responsible for ensuring that all rules and requirements for the onsite sale of cannabis goods are followed.
- (q) Any compensation paid from a licensed retailer to a licensed cannabis event organizer for participation in a temporary cannabis event shall not be determined based on, or be contingent on, the sale of cannabis goods.

§15603. Temporary Cannabis Event Consumption.

- (a) Access to the area where cannabis consumption is allowed shall be restricted to persons 21 years of age or older.
- (b) The event organizer licensee shall ensure that cannabis consumption is not visible from any public place or non-age-restricted area.
- (c) Consumption of alcohol or tobacco shall not be allowed on the licensed premises.
- (d) All requirements for onsite cannabis consumption imposed by the relevant local jurisdiction shall be followed and smoking of cannabis goods shall be prohibited in any areas where smoking is prohibited by law.
- (e) The licensed cannabis event organizer, who holds the temporary cannabis event license, shall be responsible for ensuring that all rules and requirements for the onsite consumption of cannabis goods are followed.
- (f) A licensed cannabis event organizer and all other licensees participating in a temporary cannabis event are required to follow all applicable requirements in this division pertaining to record keeping and waste management.



Safe Consumption Plan

Safe Consumption Plan

- a. CRCs- Applicant's entire team will be onsite and reachable during event.
- b. The cornerstone of the safe consumption plan is the Impaired Driving Task Force's ("IDTF") CHP report dated January of 2021 and required under State of California Vehicle Code Section 2429.7 (a).
 - a. The Task Force is made up of team members from:
 - i. The Office of Traffic Safety,
 - ii. The National Highway Traffic Safety Administration,
 - iii. Local law enforcements,
 - iv. District attorneys,
 - v. Public defenders,
 - vi. California Association of Crime Laboratory Directors,
 - vii. California Attorneys for Criminal justice,
 - viii. The California Cannabis Research Program (Health and Safety Code Section 11362.9),
 - ix. Licensed physicians, and
 - x. Various other organizations.
- c. Relevant Mission (VC Section 2429.7 (d)): "The task force shall make recommendations regarding prevention of impaired driving, means of identifying impaired driving, and responses to impaired driving that reduce the recourrence...".
- d. (Relevant IDTF Findings (Signs/Alternative Transportation):
 - a. The IDTF indicates that cannabis retailers and consumption lounges shall provide educational information to consumers through pamphlets, posters, and/or other appropriate mediums (IDTF Jan/2020 Report Page 12).
 - i. Message shall include:
 - 1. Warnings regarding impaired driving,...,cannabis use, risks associated with polysubstance use.
 - b. The IDTF finds that cannabis consumptions sites should provide information regarding locally available alternative transportation to all consumers. (id. Page 13).
- e. SIGNS/POSTERS/PAMPHLETS:

- a. In compliance with the IDTF applicant shall:
 - i. Create a poster that describes the dangers of impaired driving, has alternative transportation information on it (qr codes for uber and lyft and taxi phone #) and describe the dangers of polysubstance use (i.e., "cross fading").
 - 1. The poster shall be placed near the entry and exit of the event and throughout the event and at all retail cannabis areas.
 - 2. An identical pamphlet will be on all tables/near all seats (if/when possible).
 - 3. Below each POS shall be an identical information card (identical to pamphlet and poster (to a large degree)), and the consumer will have to read the card and physically and verbally acknowledge its messaging prior to transacting, example:
 - a. "I have been educated and/or informed of the dangers of cannabis impaired driving",
 - b. "I have been educated and/or informed of the dangers of polysubstance abuse and/or cross fading",
 - c. "I have been educated and/or informed of the responsible use of cannabis, specifically, daily limits that can be sold to me and recommendation that if I consume cannabis that I shouldn't drive",
 - d. "I have been educated and/or informed of ways to find local alternative transportation, specifically,
 1). A taxi service with phone number, 2). Uber QR code, 3). Lyft QR code."
 - e. "I have verbally and/or physically acknowledged the above education and/or information."
 - ii. Sign examples shall include messaging like (actual materials not depicted)






Example QR Code for Transporation

- f. Education/Training: Each employee serving cannabis for consumption on site shall be educated on:
 - a. How to administer the pamphlet reading and acknowledgement to each customer and elicit consumer assent/acknowledgement.
 - b. The daily limits of sales/consumption as set forth by the state.
 - c. The ways in which a customer can seek alternative transportation.
 - d. When and how to report an intoxicated person that appears to be attempting to get behind the wheel.
 - i. Management intervention. Is the first attempt at a cordial result.
 - ii. Security intervention. Is the second attempt at a cordial result.
 - iii. Respectful and polite. Request they refrain from driving and arrange for alternative transportation. Let them know it is a boundary of the event and part of the licensing that they cannot let someone who appears to be intoxicated drive away and as such if they do not comply with the cordial request to refrain from driving or seek alternative transportation (and any

- assistance therewith) then local law enforcement will have to be called.
- iv. Last resort for noncompliant and dangerous situation will be to contact local law enforcement.
- v. Education on: Recording and documenting the interaction.
- e. Product training so that they understand which products produce varying and material effects so they can understand when a consumer is using a material amount.
 - i. *Concentrates, flower, edibles, etc.
 - ii. How to educate the consumer on the varying effects of different products:
 - 1. Example:
 - a. Edibles take time for the experience to manifest.
 - b. Concentrates are immediate and strong, etc.

g. LAST CALL

- a. 1 hour prior to closing (approximately 9 pm), Applicant shall begin informing consumers of the closing time and invite them to make travel arrangements and begin preparing for transportation. Applicant will also advise them to be quiet and mindful of the surrounding area.
- b. Applicant to cease all sales and onsite consumption <u>promptly</u> at 10 pm.
