<u>Director Scott:</u> Now that the fair is wrapped up where do we stand on the Junior Livestock are, they all taken care of?

<u>CEO Wuersch:</u> We had a total of 262 (two hundred and sixty-two) payouts. Our bank record shows that 171 (one hundred and seventy-one) of those checks have been cashed and 91 (ninety-one) of those checks has not been cashed yet.

#### 3.) CCA REPORT:

<u>Director Yeager:</u> CCA had a special meeting two Fridays ago they are currently in the process of negotiating for a new executive director. We had the final interviews for the final candidates and a recommendation was made. The decision has not been made yet it is currently in process but once it is official, I will make sure to share that information with the Board. We did have a Board meeting to approve additional policies that needed to be done for the final transfer of separate authority from the previous structure. The interim right now is Brian Hubanks.

## 4.) MARKETING COMMITTEE:

<u>Director Palumbo:</u> Carl and I met, and we went over the new proposal from the Adorn Group. We are going to go back to them with some changes and requests. We still feel this is the direction we need to go with this group. The proposal with the group will not just be for fair time it will be for everything that is going on, on the fairgrounds, all the merchandise, Media, and sponsors

#### b.) TORO WAPO: Amendment to contract.

<u>President Magnuson:</u> Xavier would like to talk about the changes he would like to make to his rental area. Everything has already been submitted to the rental committee, but he would like to address the Board.

<u>Xavier Ortiz:</u> When I first took on this project, I had a lot to fix and a better reputation to build. I am having to compete with big guys like AEG (Anschutz Entertainment Group) and Live Nation Entertainment Company. So instead of competing head to head with those guys I want to hit them where they are weak. The arenas they have folks can't dance at but here they can. We have the space for them to dance and roam around we also have the rodeo that they don't have. I am working with some of the best bull farmers. So, with that kind of partnership a new opportunity can arise. So far, I have only been having bull riding events. In Spanish they are called Jaripeos the definition of a Mexican rodeo. Its not as formal as what you guys might know like in Huston or Dallas because it's not a point-based event. Then there is a different rodeo you would know it as roping it's called Coleaderos. I was looking into that for about six months, but we don't have the venue, the parameters or the structure to meet the parameters of the national

Charreada Mexican rodeo association. The only venue in all of California that does meet the parameters is Pico Rivera sports arena. I started to talk to people in the industry and they asked me if I could build the arena to meet the parameters and that if I could they could get all those people that are in the Inland Empire to come to this location instead of going all the way out to Pico Rivera. Its going to be very expensive. So, what I am asking for is I must pay rent of \$48,000.00 (forty-eight thousand) dollars for this coming year. I am asking that I don't pay that rent and I will pay for all the improvements that are needed to meet the national Charreada Mexican rodeo associations parameters. With having more shows, a month that will bring in more revenue to the fair. I will put in writing that if I don't make you the \$48,000.00 (forty-eight) thousand dollars that I will pay you whatever the difference is.

<u>President Magnuson:</u> I did turn everything over to our rental committee because we do everything by committee. Marisa (Director Yeager) did you and Brad (Director Scott) get a chance to go over it?

<u>Director Yeager:</u> Yes, we were able to have a summary conversation of what had occurred when Ron (President Magnuson) had stepped in for Brad (Director Scott). My recommendation was to bring this before the Board because it is a two-part conversation. It's the business side and then also I wanted to talk about the nature of the rodeos there has been a history of concern. So, I wanted to make sure that it was all talked about and that we all understand the actual activity of a Mexican rodeo. We need a little more description who is the oversight of the activity, what is the history at the Pico Rivera center. I just want to make sure we have a full understanding because we are changing the culture here on the fairgrounds to have this activity. The purpose of this conversation today is that we all understand this type of activity.

<u>Xavier Ortiz</u>: When the question about the treatment of the animals was brought up in our meeting I spoke to my guy and he said its Roping its no different than normal rodeo that the general public is used to. He said in the four years he has had it at his location there was only one incident. There is always a vet (Veterinarian) on site and unfortunately in this incident the animal was put down.

<u>Director Palumbo:</u> At this type of rodeo do they do the Horse Tripping? <u>Xavier Ortiz:</u> I am not sure (makes a phone call to his contact told him that Horse Tripping has not been allowed in the United States since 1994 and they don't do it.

**Director Almiron:** What is being asked of the Board?

<u>Director Scott:</u> I want to know that everything is sanctioned and that there is an authorized third party that does the inspection to make sure that everything meets the requirements for safety and certifications.

<u>Xavier Ortiz:</u> The National Association of Charreadas would be the organization that would come out and inspect everything. Can I bring in my business partner to come in and answer all your questions?

<u>Director Almiron:</u> So, at this time the rental committee does not have a recommendation for the Board?

<u>Director Scott</u>: No not at this time I wanted to bring the discussion before the board so that everyone's concerns could be addressed, and we can all fully understand the changes.

<u>Director Yeager:</u> What we need is something stating that in lieu of rent these are the capital improvements that you are proposing to bring in a new activity and all the details of the new activity that you want to bring on to the fairgrounds. So, what would be helpful for the next discussion meeting would be to have the history of this event at the Pico Rivera arena. What kind of oversite is there for the safety of the animals? We need more information to help everyone better understand.

<u>President Magnuson:</u> Lets table this conversation and have it go back to the renters committee and have it on the agenda for next month.

c.) <u>SATELITE WAGERING:</u> Moving Satellite Wagering to Harrison Hall.

<u>President Magnuson:</u> This is just getting started so what you all have is a copy of the letter of intent.
