<u>CEO Wuersch:</u> After we received the letter from Director Yeager, we replied to the Vendor with issue resolved, and Henna Crone is happy to return for the 2019 Fair.

USC (University of Southern California):

<u>CEO Wuersch:</u> This was a program that Eastern Municipal water district sent our way from USC. USC has a program for developing back flow valves and big farming equipment and USC cam and replaced all of our equipment. USC students monitored the equipment for one year. This is the letter from the School to thank us for participating.

<u>Director Yeager:</u> So, we got some new equipment by participating in this exercise?

CEO Wuersch: We got the main shut off and 2 smaller ones and a new back flow system. It could be valued at seven or eight thousand dollars' worth of equipment.

<u>Director Yeager:</u> Is there a log or tabulation record kept for improvements like this that are done on the grounds?

5.) CFSA Report:

Monthly Update

Director Yeager: Is slowly moving to CCA (California Construction) Authority. In 2008 the staff of CFFA (California Fair Financing Authority) was absorbed into CDFA (California Department of Food and Agriculture) - Director Yeager passed out a hand out of the Agenda for last week-In the agenda the Board approved everything HR. Also, on informational item #2 (two) it is an informational update that now CDFA will be knowns as CCA. There is an organizational update on who is in that authority and what they will be handling. This authority handles all construction projects on all the Fairgrounds in the state of California. They monitor and there is an oversite financial roll with this authority. The Board is given an update about new project, pending projects and deferred maintenance projects and where they are at in completing their project. Now that there is a Sales Tax revenue that is garnered on California Fairgrounds now there is going to be a fund that CDFA is going to be determining the distribution of those funds throughout all Fairgrounds in the state of California. So now there is somewhat of a review for sources of funds that will be available. The priority with those funds is the Deferred Maintenance projects.

9) ACTION ITEAMS:

a.) Perris Auto Speed Way: Approval on Contract Renewal for the PAS. **Don:** He wants to add the language to be added in regard to any third party from using Oval Entertainments Intellectual Property for the promotion of their events. He would like Paragraph 11 to state: The 46th District acknowledges that the dba (Doing Business As); Perris Auto Speedway and Perris Auto Speedway Logo are the Intellectual Property of Oval Entertainment, LLC (Limited Liability Company). The District will inform any Sanctioning Body, Promotor, Non-Profit, Club or Organization renting the facility for a Motorcycle Event, that the use of the dba; Perris Auto Speedway and the Perris Auto Speedway logo are strictly prohibited. If the District or any Sanctioning Body, Promotor, Non-Profit, Club or Organization would like to use the dba; Perris Auto Speedway or the Perris Auto Speedway Logo, Oval Entertainment agrees to negotiate a Licensing Agreement with the respective party for hat specific event. President Magnuson: Ok lets table this until next month so we can talk it over.

CEO Wuersch: I don't see why we can't do this for him.

<u>Director Yeager:</u> I would ask that this be sent to Sacramento for review that everything is in legal order.

Motion to approve the addition to the amendment made by Director Yeager. 2nd Director Hurtado

b.) Deferred Maintenance: CEO Carl Wuersch was information.

<u>CEO Wuersch:</u> - CEO Wuersch passed out the old Deferred Maintenance list and the new Deferred Maintenance list. — Reviewing the old list with what has already been done, what can wait, and what still needs to be done and the priority that it needs to be done in.

<u>Director Yeager:</u> This is a list that was done about 3 (three) years ago in one of the strategic planning meetings. The state is looking at this third round of funding for fairs to be designated emergency evacuation centers. So, when reviewing the new Deferred maintenance list, we need to keep that in mind when we make the case for the funds and what repairs will benefit our Fairgrounds to be an emergence evacuation center.

<u>CEO Wuersch:</u> On the Harrison Hall painting, that was already done in 2016. The dance floor has not been replaced and the patrons like not having the are dance floor and we don't have to worry about it being a tripping hazard. Fence repair, we have had some done. The parking lot stripping; we could probably re slurry and strip the PAS area but other then that there are so many other repairs that need to be done that will be on the new list. Well motor and pump; this will get us off the meter water and we have a great hole.

<u>Director Bruno:</u> Didn't they offer you some re-claimed water? That might be less expensive than doing the well.

<u>CEO Wuersch:</u> They offered us the re-claimed water when they brought the line down Ramona Express Way, I think in 2015. I think the discussion at that time came down to the cost of the electricity to run it and the actual meter cost.

<u>Director Yeager:</u> It might be best to have a side by side comparison. You should reach out to CCA because of this new effort of making improvements to make the Fairgrounds a better evacuation center so we need to know what they expect of us.

<u>Director Hurtado:</u> Is there a time from on this to be submitted?

Director Yeager: Yes, it needs to be in by March 31st

<u>CEO Wuersch:</u> On the Satellite wagering seats. I have someone that can re-upholster them very inexpensive so I think that can be done in house. The carpeting in Satellite wagering was just cleaned and it looks nice and we don't have any trip hazards.

<u>Director Yeager:</u> What about the Satellite TV and Screen repair?

<u>CEO Wuersch:</u> We just did those 6 months ago we used new bulbs and put the TV's that where in the pews out to replace the old TVs. The parking lights need to stay on for the new list. For the messaging board on the corner. I got some quotes for new LCD panels and it would be before labor \$90,000 (ninety thousand) so we are just going to get some bulbs to replace the dark spots and only spend about 7 (seven) to 8 (eight) thousand. This will get us by until we get a sponsor to help us update the sign. Restroom repairs – Donny did a bunch of repairs of the North and South side. The bathrooms in Harrison Hall and Satellite wagering are working.

<u>Vice President Bruno:</u> What about the showers in Livestock they where not working this year.

<u>CEO Wuersch:</u> The showers are going to be taken care of. They have all new toilets that where working great this year. – Satellite Wagering Lights we had those done right after we replace the carpet after removing the pews. Light repair in Harrison Hall we have most of the lights fixed the neon that is broken in there we are not going to repair it we will replace it with the newer type rope lights that look just like the neon lights. Drinking fountains, I think we have 2 by the north bathrooms that don't work but all of the others are working fine. Water line repair that will be park of our exterior lines. The inside plumbing in Harrison Hall has been fixed. The bleachers I'm not sure on. Donny yours have been done for quite a few years. So, I am not sure what this is because all the portables are all ADA (Americans Disability Act) approved.

<u>Director Yeager:</u> Were the stairs fixed.

Don Kazarian: Yes

<u>Director Hurtado:</u> Why are we going through this list when we are narrowing it down to just 5 and not this whole list?

<u>Director Palumbo:</u> Because we are seeing what has already been done.

<u>Director Yeager:</u> He is making his recommendation after looking over the old list. Before we can have that conversation, we need to know where we are at.

<u>CEO Wuersch:</u> Sewer hookup – we have two legal dump station and it is south of the livestock area and one by the Go Cart area.

Director Palumbo: So on to the 5 recommendations

<u>CEO Wuersch:</u> The Satellite roof. Repairing the asphalt in the parking lot. The water situation (the well or re-claimed water). Electrical issues and lighting on the Fairgrounds.

Director Yeager: Are these prioritized?

<u>CEO Wuersch:</u> Yes, the Roof in Satellite is number 1 priority and then the asphalt then electrical then water.

Motion made by Director Yeager with the priority to be deferred to CCA. 2nd Director Palumbo.
