**CEO Wuersch:** I got a call from the Governor's office and I spoke to Arturo. He wanted to give me a heads up that there are two hundred and sixty State locations and we are one of the seven that was selected. He said not to panic and to just wait it out. I need volunteers for different departments to help for this year's fair. We are making big progress in the renovations in Harrison Hall. I am working on getting the Dolls taken care of the right way and myself and Brad are working with the Family and we are all in agreement that the schools are the best place for the dolls so that they can continue to be used for educational purposes. One of the event policies that we are going to change for Interim events after speaking to the Deputy Marshal is, we are going to have two deputies to work with security for that event. We are going to work with La Que Buena a Mexican radio station and with KFRG radio station again. We offered La Que Buena Fiesta Village for them to put performers on. Thank you to our new chairs and I am very excited for 2020. We will have the budget for the Master Gardeners project next month as well.
